Goodwill Rescue Mission (GRM) is open 365 days a year providing food, shelter and guidance to some of Newark's most needy men, women and children. Each year GRM provides care for over 100,000 chronically homeless individuals, many with life controlling addictions. GRM serves between 250 -300 meals a day and has approximately 200 beds available for men and women between our emergency shelters and comprehensive life transformation programs. Meals and shelter are provided 7 days a week. Approximately 51 men and 14 women sleep in our emergency shelters each night. Our long-standing relationships with a variety of other community organizations and agencies uniquely position us to ensure that all of a person's felt needs are addressed, including physical, medical, emotional
